USE OF CAMPSITE & OCCUPANCY INFORMATION

Camping is an outdoor recreational activity and the campground is a designated area where camping takes place. It is agreed by the parties that the intended use for the site is for seasonal recreational and vacation purposes only and as such the trailer cannot be used as a residence. The camper hereby undertakes and agrees that they will inform any family member and guest, visitor or other person attending the Camper's site as to the park rules and is responsible for them while at the park. The park is open for seasonal recreational use by the Seasonal Occupant (s) and his or her guests with services specified for a season commencing from the park opening date May 15th until October 15th in any year. This Camping Agreement must be approved by Pike Lake Golf Centre Limited no later than October 12, 2018 to reserve the subject site. *See Section T**

This license is personal to the Seasonal Occupant(s) and Owner of Pike Lake and is not transferrable. The Seasonal Occupant(s) acknowledges and agrees that no business or sales of any kind shall be advertised or conducted on the premises.

Renting or leasing out your trailer is strictly prohibited. *See Section S**

Services and Fees: The seasonal occupancy fee includes the safe water fee, MPAC trailer taxes, garbage fee and winter storage fee.

- Hydro meters will be read and invoiced 3 times per season: June, August & October
- Propane rental tanks & Pontoon Boat Fee invoiced May of each year (includes boat trailer storage from May to October.)
- Extended Season – Applies to persons using their site more days here than away during the season, invoiced June of each year (*Extended time of stay with written approval from Pike Lake Management*)
- Maintenance of Site and Winter Storage Fee – applicable charges may apply *See Section H, Rule #2, See Section T, Rule #4**
- **A NSF fee of \$75.00 + HST will apply to all returned payments.**
- Pike Lake requires a valid credit card on file or a \$200 deposit for charging privileges
 Credit Card on File \$200.00 Deposit (Due May 1, 2019) *See Section Q**
- Park brokerage services MUST be used for sales within Pike Lake Golf Centre Limited. Trailers older than 20 years cannot be sold on site or brought seasonally into Pike Lake. Any camper that brings in their own trailer and is on a seasonal site cannot put their trailer up for sale unless it is sold off the lot. *See Section S, Rule #2**

TERMINATION/CANCELLATION OF AGREEMENT

The Owner may, upon written notice to Occupant, in its absolute discretion terminate/cancel this agreement as a result of:

- (a) failure of the Occupant and/or Occupant's guests to comply with all campground rules and conditions; or
- (b) conduct of the Occupant and/or Occupant's guests within any part of the Owner's facility at Pike Lake which is deemed unacceptable in the absolute discretion of the Owner.

The Occupant agrees to vacate the site, including removal of trailer and clean-up of site both at the Occupant's expense, in accordance with the said notice of termination/cancellation of this agreement.

I, the undersigned trailer occupant hereby warrants, covenants, and represents that during the term of this agreement shall maintain in full force and effect liability insurance coverage in respect of my trailer, my golf cart if any, my boat of any kind if any, and the subject site. I agree to deliver to the owner satisfactory proof of said liability insurance coverage upon written request from the owner.

This agreement is for the benefit of and is binding upon the undersigned Occupant and Owner. I (we) acknowledge that I (we) have read pages one through two, understand and agree to comply with all the provisions in this agreement, the Campground Rules & Conditions and that Pike Lake Golf Centre Limited is not responsible to me, my family or associates for any injuries suffered or loss due to theft, hydro loss, fire or other causes, in respect of which Pike Lake Golf Centre Limited is not responsible, liable for or negligent.
